Double your donation and reap the benefits of increasing your contribution to Bard on the Beach. All employer-matched gifts are eligible for the benefits of the **total donation**. For example, a donation of \$300 matched dollar-for-dollar by your employer qualifies you for the *Midsummer Magic* (\$600) donor level with access to the Season Launch Reception, extra dress rehearsal passes and the privilege to be the first to purchase tickets for the upcoming season! Not all companies match gifts on a dollar-for-dollar basis, but some will match volunteer hours with cash donations.

Matching Made Easy

To get your donation matched by your employer, speak with your HR, Payroll or Corporate Giving Departments and ask about their donation matching program. Many companies will ask you to complete a matching gift form which you will then need to submit to Bard with your gift. After that we'll take care of the rest. Following your company's procedures may not ensure a matching gift, but it will increase the likelihood of success.
