All items are sold "as is", and the VIWF and Bard neither warrant, nor represent, and shall in no event be responsible for the correctness of the description, genuineness, authorship, provenance, value, or condition of the Property. No statement contained in the description of the auction items or made orally either online or elsewhere shall be deemed to be warranty, representation, or assumption of liability. Neither the LCLB nor the LDB is responsible for the quality of the auctioned wine or liquor.

## **AUCTION ITEMS**

The VIWF and Bard reserve the right to withdraw any auction item. In case of discrepancy between the item's description online and the gift certificate or wine received in person, the gift certificate or the physical item shall be deemed the valid description. All service items or experiences must be used within the period stated on the certificate.

### **TERMS OF BIDDING**

Bidding is open to anyone in Canada other than residents of Quebec. However, all sale transactions following the auction will occur in British Columbia. Buyers are responsible for pickup in BC.

Title to all alcohol sold in the auction passes to the Buyer (successful bidder) in British Columbia. The Buyer is solely responsible for and must make arrangements for pickup of any alcohol items from the designated pickup location in BC. Any subsequent shipment of the alcohol is the sole responsibility of the Buyer. We make no representations as to the legality of shipping alcohol to other jurisdictions or in respect of a Buyer's ability to do so. This transaction is governed exclusively by the laws of British Columbia.

All bidders/purchasers of wine or other alcoholic beverages through the Auction must be 19 years of age or older. Proof of age may be required prior to the transfer of any purchased lots.
